The Brown collection is a rich source for Kansas and national railroad history. Howard Brown spent the majority of his adult life gathering and collect railroad documents and memorabilia. Brown was employed by the Missouri Pacific Railroad, working as a brakeman and conductor. His service with Brotherhood of Railway Trainmen & The Brotherhood of Railway Conductors spanned over forty years of involvement. His collection consists of the following: Missouri Pacific Railroad documents, newspaper files on railroad related subjects, a pamphlet collection (with various entries from leading railroad companies) railroad timetables, union and lodge records dating back to 1890 for Brotherhood of Railroad Conductors Local #137 and the Brotherhood of Railroad Trainmen Local #65 (Osawatomie, Kans.), strike histories on the Missouri Pacific system, arbitration records, and personal letters sent & received by Howard Brown.

Kansas Town and Land Company

The records in this collection provide information on railroad development and community growth in Kansas and throughout the region. Local and community histories can be traced to original platting and sales of land. Documents included are contracts, deeds, and plat maps which provide a precise insight into the creation of boundaries, plats, and land transactions. The correspondence in this collection deals with a variety of right of way and land disposition concerns. This information on the origin of Kansas communities may not exist elsewhere. Subjects included are negotiation with county officials over assessment and taxation practices; donation of land for public schools, colleges, churches, and assorted recreational facilities; negotiation of terms for the lease of pasture and agricultural land uses; growing conditions and yields of rental crops; rental or lease of company owned buildings and facilities; extensive communication with local real estate agents, bankers, and lawyers who represented the company's interests. The majority of the records center on the official activities and correspondence of Mr. Ernest Warren Cline. He was Treasurer and Secretary-Treasurer of the Kansas Town and Land Company as well as Right of Way and Tax Agent for the C.R.I.&P. Railway Co. The collection contains office records, receipts and disbursements, correspondence and legal documents, and Town Company Record Books. These town site volumes list each property and the disposition made of each. They are supported by original and duplicate title papers on file and have entries that also show the disposition of all properties.

Leavenworth Depot and Railroad Company

This collection includes a variety of materials. There are minutes of stockholder and board of directors meetings which give information about the election of directors, company officers, general policies, and salary changes. This material also includes calls for meetings and proxies for those directors who were not able to attend the meetings. Most of the information about this company is found in the correspondence files of the depot superintendent and company officials. Topics discussed include payments to retire the company's debt, personnel problems, accident and damage claims against the depot company, and correspondence with the United States Railroad Administration during World War One. Also in these files are letters about a lengthy controversy between the depot company and the Chicago and Great Western Railroad Company about its failure to pay its bills assessed by the depot company. Several letters show the procedure for investigating and settling claims regarding accidents and damages. There are letters for health officials recommending changes when threatened with a typhoid epidemic. Other correspondence illustrate the day to day problems of depot operations such as requests for passes, selection of paper drinking cups, handling rail from the trains, installing coin operated stalls in the restrooms, bonding employees, and purchasing insurance covering depot property and operations. The general files also include correspondence with federal (ICC) and various state regulatory and taxing agencies.

There is some correspondence relating to depot maintenance and to the activities of the ticket agent. There are leases and contracts for depot concessions or repair or remodeling work required at the depot. Material from World War I includes the circulars and bulletins issued by the U. S. Railroad Administration, reports prepared for the administration and a separate set of accounting books for the time it existed. There is also some correspondence and daily reports of troop movements through Leavenworth Depot during the Second World War. Financial journals in this collection consist of monthly "statements of operations", journals summarizing company transactions monthly, ledgers serving as original entries for specific items in specific accounts, cash books, voucher and bills collectible registers, letterpress copies of bills and vouchers, and time books for employees. There are also sample forms used in daily operations and bills with information about local businesses. This collection provides information about the specific company, depot companies in general, depot companies in relation to railroads, relationships between the railroad industry and state and federal governments, and information about Leavenworth, Kans.

There is a volume containing names of officers and or members of the Brotherhood of Railway Clerks in Missouri, Kansas, and Oklahoma. Early entries in these diaries contain accounts of wages, commissions, tips, and freight payments while George was an employee of the express company. Once he was elected to the Brotherhood office, George recorded lodge information including names and addresses of members, officers, organizational activities, trips made for the Brotherhood, negotiations with Government regarding control of railroads, notes on grievances, secret signals for messages and identification between union and railway men, daily appointments, and information concerning his retirement.
